COSTA BRAVA MEDITERRANEAN FOODS-GRUP CAÑIGUERAL (hereinafter referred to as the Organisation or the Group) is committed to food safety and the quality of its products. In pursuit of this responsibility, it undertakes to work with suppliers in its chain who comply with its standards and regulatory requirements.

The Organisation recognises the potential of genetic technology in the medium and long term to improve the quality, availability and nutritional value of food, and to increase food production for the benefit of the planet, but at the same time it accepts that this can only be done responsibly by complying with ethical measures and, of course, the legal requirements established in our country.

Therefore, our Group will only consider working with genetically modified ingredients (GMOs) when they have passed food safety assessment procedures and have been registered as safe for use in food production by the WHO, FAO or other independent scientific bodies.

Traceability of GMO products will be carried out periodically throughout the stages of production, processing and distribution by means of documentary or on-site audits among those suppliers who may work with this type of product.

To ensure transparency, the organisation will also verify that suppliers comply with the required labelling, if applicable, and undertakes to do the same, complying with national laws and labelling regulations related to GMOs when required.

The application and scope of this policy covers all products manufactured at **Grup Cañigueral IMP, S.L. plants**, as well as all activities related to the promotion, awareness and information on responsible and healthy habits, consumption and purchasing.

This policy is made available to all internal stakeholders, and information is provided on the possible disciplinary measures that would result from non-compliance with the provisions of this document. This policy is available to external stakeholders on the Group's website and communication channels.

Both the management and sustainability committees, as well as the executives and managers of all the companies in the Group, are responsible for monitoring and enforcing the provisions of this Policy.
